Lieutenant Columbo and the Olof Palme murder

The investigation into the murder of Prime Minister Olof Palme in 1986 is officially closed. The murder was carefully and professionally planned and was carried out by a professional elite. Lieutenant Columbo is known all over the world from the tv-series. 'How do you do, Lieutenant Columbo. In my wildest imagination I could never have anticipated being visited by the world-famous Lieutenant Columbo.'



'How do you do, Mr. Head of State, I hope I don't disturb. My name is Lieutenant Columbo and I want to ask you a couple of questions.'



'My job is to solve the murder of Prime Minister Olof Palme.'



'Well, is it? It's a gigantic story and so far nobody has managed to do it. If you really want to solve the murder, you'll need a change of addresses, because I can't help you. And why do you come here?'



'In my job we don't pay a visit to somebody unless we have a clue. I visit you because you're the Head of State of the Kingdom of Sweden. As such you should be familiar with what's going on in this country. You knew Palme, didn't you?'



'Of course I knew him, but I know nothing about the murder, so I can't help you. I know this: there is a number of leads, none of them realistic.'



'Olof Palme was shot to death on Stockholm on February 28 1986 at Sveavägen, at 11.21 p.m. What did you do that evening? Home or away? What was your reaction?'



Olof Palme was shot to death at 11.21 pm, February 28 1986, at Sveavägen in Stockholm. Police and ambulance arrived late.



'I don't quite remember what I was doing, but I was in Storlien. I was briefed about the murder, my first reaction was that it was very quick.'



'One thing strikes me: Other criminal cases require a quick response from the police, but this didn't happen here. Then we heard that Palme's data had been deleted and that the murderer had already left the country. Two questions: Why was Palme shot and what did the police do?'



Lieutenant, Palme was a well-known politician around the world. He had fans and adversaries, abroad as well as in Sweden. The motive might be political, and you have to ask the police about why they were late and what they did.'



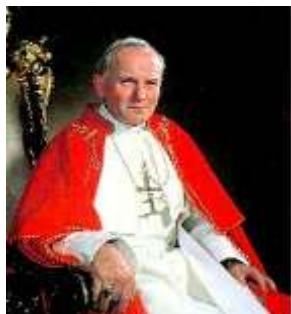
'When did Palme make his last public appearance as prime minister?'



'If I remember correctly, Palme took part in an anti-apartheid conference with ANC leaders against the South-African government in mid-February here in Stockholm.'



'The Apartheid era in South Africa: extensive, bloody world politics. Palme always sided with the weak, poor and oppressed. Before the murder Palme visited Pope John Paul II in Rome. Their secret discussions took place behind closed doors. When a top politician visits the pope in the Vatican, there are never any closed doors when they meet. What do you think, did they discuss politics?'



The last time, before the murder, Palme visited Pope John Paul in Rome and behind closed doors the discussion dealt with the largest and most secret issue. Palme received a mission. He had to answer either yes or no. Palme said 'no'.



'Strange question. I have no idea what they talked about behind closed doors. He hasn't told me anything about it. Obviously, they both took the secret to the grave.'



'I can agree they never disclosed what they had been talking about. John Paul had a personal coat-of-arms, an illustration of his papal mission. You can still have a look at it. The coat-of-arms looks like the Swedish flag: blue and yellow and the letter, **M**, clearly visible. What does it mean, what does the coat-of-arms mean? Can you explain this?'



'Now again, lieutenant! How could I do that? I'm not interested in such issues even if I'm a Christian. You can ask the Arch bishop of the Church of Sweden. She might have an answer to your question.'



'There is something wrong here, the equation doesn't add up. The message is either religious or political. – If we analyse the Pope's coat-of-arms we ought to know what happened in Sweden, since **M** refers to Jewess Mary, the cross refers to Christianity, the Crucifixion. The centre of events was in Sweden, as illustrated by the Swedish flag. You can see here, clearly.'

'OK, I'm leaving, but I'm not finished yet, there is more.'



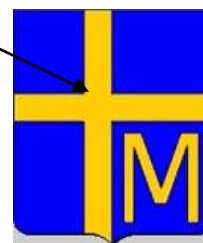

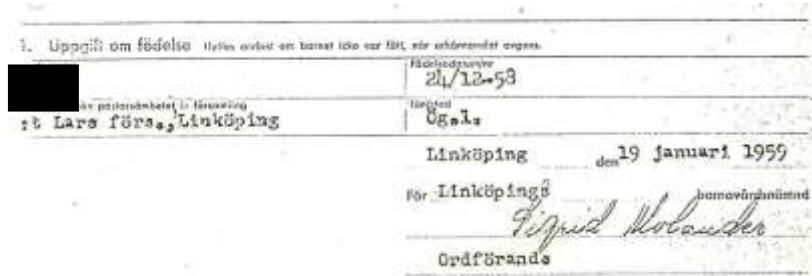




A document dated September 18, 1958 states that the woman, Maria, was pregnant.



On September 18, 1958 Tibor Kemény was made to sign an acknowledgement of paternity including allowance to the coming baby boy. His Swedish was bad, he thought his signature was for the child's accommodation. This signature gave Sweden the wealth of the world.



The agreement was dated January 19, 1959. There is no information on the child's name, civil registration number, gender, his whole identity is missing. We can only understand that someone was born on December 24, 1958. This means that the document is invalid with no legal importance. 'I understand nothing. Why are you so upset? I'm only asking questions relating to a paternity issue which was an ongoing issue during many, many years. A head of state should be aware of what's happening in his country. In 1960 all three moved to Stockholm. But there was an even bigger problem. Tibor E was murdered at the beginning of the 1970s in Stockholm, during Olof Palme's time in office. King Gustav Adolf VI was the Head of State.' Is that correct?'



'My paternal grandfather died in 1973, he was old and sick. Then I became king. I was a rookie, young and inexperienced. I remember nothing.'

'What you say is peculiar. Jewess Maria was married to a Danish civil engineer, Kristian J. They all lived in the same municipality as you, from 1966. Tibor E called Tibor Kemény in the spring of 1971 to tell him that he was going to hospital to have an operation, he was scared and worried. He asked Tibor Kemény to come with his, but he could not because of work. Little Tibor promised to get in touch as soon as he was out of the hospital. He called Timor Kemény 'dad'. But he never called.'



King Gustaf Adolf VI affixed his seal on Tibor Kemény's paternity issue on **March 30, 1966** at the Stockholm Castle. Duty Above All according to the above document from January 19, 1959. From this date and onwards the Royal Court, the King, was responsible for the handling of Tibor Kemény's paternity issue which lacks both legal and biological connections to him. 'How can you explain that the Head of State Gustaf Adolf VI classified Tibor Kemény's paternity issue without any information from the Court? Pope Paul VI also classified Maria and her son.'



'Lieutenant Columbo, you should never have come here. I'm getting angry and damned furious, you must leave me alone. Get out of here!'

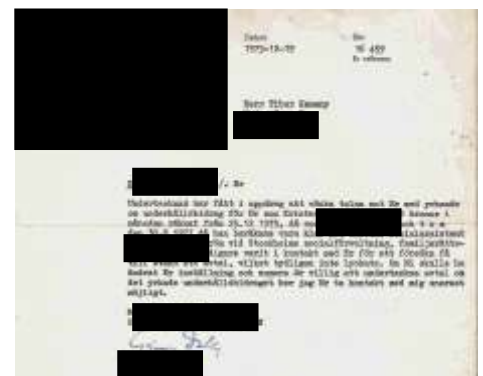




'Lieutenant Columbo, I don't understand what you're talking about. I can't comment on individual cases.'



'Oh, Head of State. You'll have to excuse me again, but another question popped up, one that interests me. – In the middle of the 1970s, the DSS in Stockholm, the family law department, sued Tibor Kemény. He was supposed to pay an allowance to Krister R. Tibor had never heard of Krister R, he had never even seen him. Krister R. was only 17 years old and wanted to continue his studies. Simultaneously I had to find out that Tibor E was at the bottom of his class and was not interested in continuing his studies. He lived in another world. How can a situation like that occur in your country, where compassion and the issues of children's rights and protection are so important?'



The authority's reaction on Tibor Kemény and allowance to Krister R according to an invalid 1958 document. T. Kemény did not see this agreement until the 1976 court procedures.

' Can you explain this?'



'T. Kemény called and talked to a DSS officer. He told her he wanted to meet Tibor E, he had not seen him during the last five years. She answered that T Kemény was not allowed to meet the child, he was only allowed to pay the allowance.

T. Kemény decided to refuse and ordered blood tests regarding the Krister R paternity issue from The National Board of Forensic Medicine, the blood serology department in Solna.

Krister R and Tibor E had identical identity documents.'

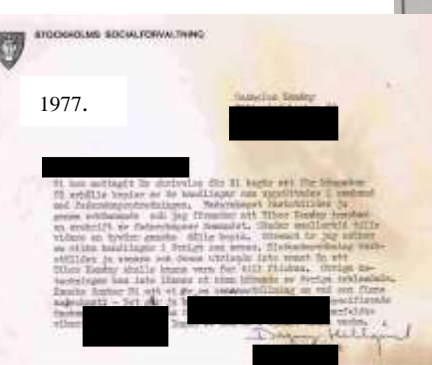

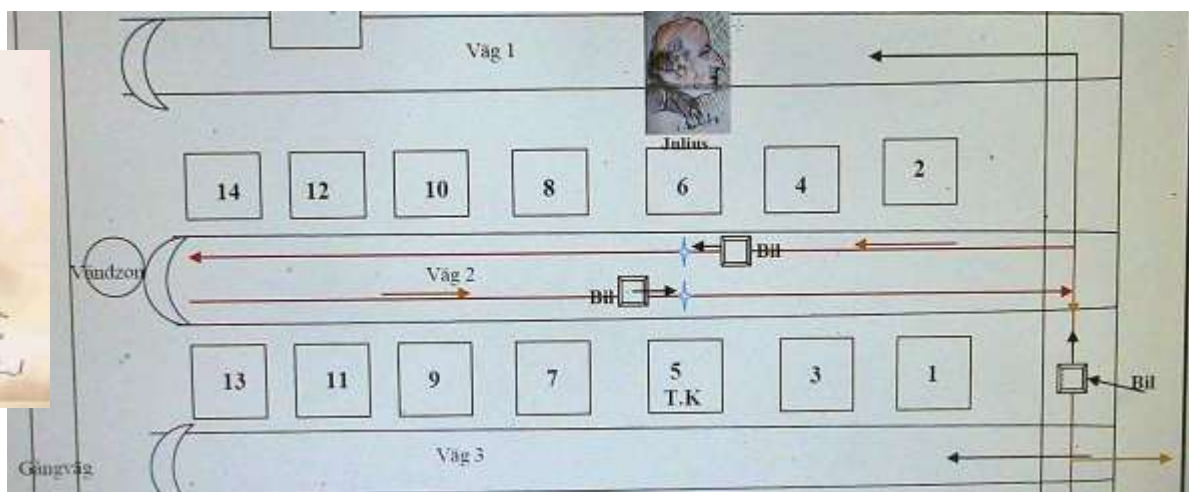

The blood examination was finished in July, 1976. Its conclusion was that T. Kemény was not the biological father of Krister R. The same rare hereditary dispositions as those of T. Kemény were found in Krister R's blood. It was proved that Krister R and Tibor E were not the same person, Krister comes from T Kemény's Hungarian family. But T. Kemény lost in all three instances (district court, court of appeal and the Supreme Court. He was sentenced to pay the allowance.



In spring, 1977, the DSS officer replied that she could not send documents connected to the paternity issue, but the blood examination suggests T Kemény could be the **girl's** father.



In a veteran car, Krister and Maria R drove past T. Kemény's house #5 and looked at #6 opposite, the house of Julius, a Jewish man, at the time deceased. This was in July 1977, with Krister R behind the wheel. He seemed to be at least eight years older than Tibor E. More info at **Industry, The Lamb's Will**, pp 20 - 21 and **Deity**, page 58.

Krister and Maria had a close look at Julius's house (they were planning to buy it), they then left the area. T. Kemény: 'The driver looked like my cousin.' His blood contained rare dispositions which can be found in the Kemény family and Krister seemed to be a hybrid. Now he understood that Tibor E was murdered. Krister R assumed his identity, that is why T. Kemény was not allowed to meet Tibor E.

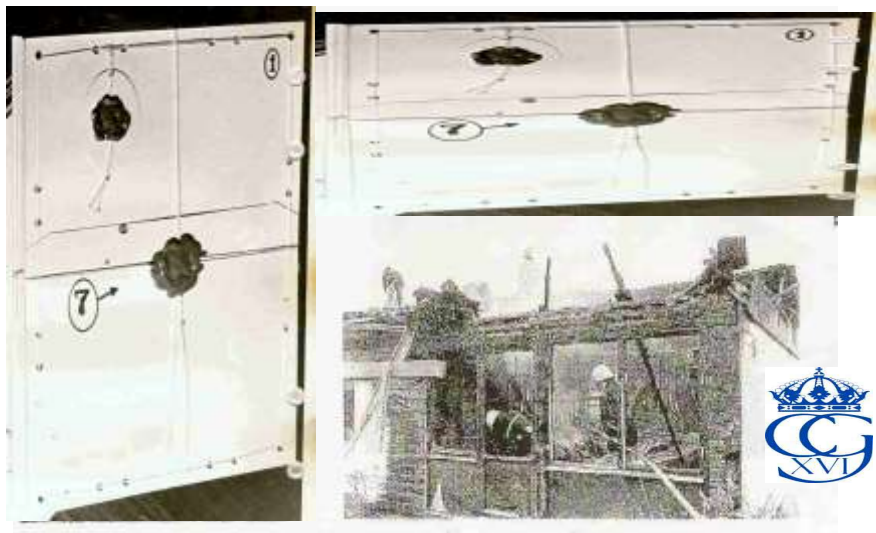
'Being the Head of State, what do you think of this God phenomenon which took place in Stockholm? Can a public agency support murder, fiddling, fraud, forgery, etc. in a paternity issue? Who sent Krister and Maria R to have a look at Julius's house?'



'Lieutenant Columbo, this is pure madness, I'm no authority, If an authority would commit a crime, it's up to the authority. I have nothing to do with it. Do you understand, lieutenant?'



'You know nothing, but the fight with T. Kemény is still going on in a brutal and dirty way. Both the police and the prosecution office know about Kemény's paternity issue, everybody but the Head of State, who is supposed to know what's going on.'



On September 19 at 2 p.m. four desperate police officers stormed the house where T. Kemény lived with his children. Their orders were to arrest T. Kemény and take him to the madhouse as a prisoner. 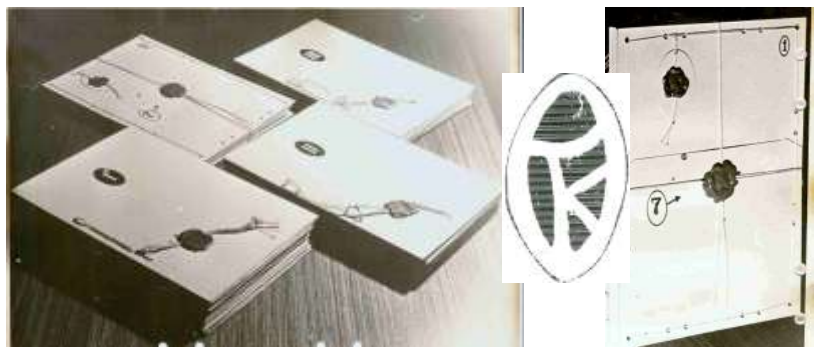
‘Of course, the Head of State knows nothing about this incident, the kidnapping and the fire.’

‘On their way to the hospital, in the car, the police officers said that they had orders from above to arrest T. Kemény and take him Långbro mental hospital. Kemény asked why. One of the officers said something about a **Scroll**, but they didn’t know what it was. ‘Now I understand,’ was Kemény’s answer.

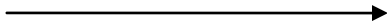
In tandem with his paternity issue, T Kemény also wrote his will with the seven seals. He handed the package over to the Danish embassy on March 13, 1978 with a stamped receipt. The package was sent to Prime Minister Jørgensen. The only ones in Sweden who knew about the scroll were you as Head of State via your cousin, and later on Olof Palme.



You don’t remember?’



'Lieutenant, I can't answer your question. You have to leave, you can't stay here.'



'I'm about to leave, but it is evident that you can't answer my question. I believe it was you who sent T. Kemény to Långbro hospital. The question is still: Why?'



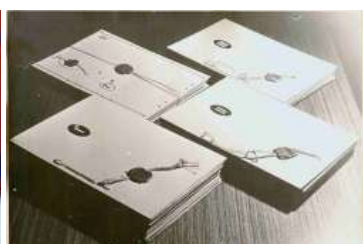

'Lieutenant! I say again that I can't answer your questions. You have to get out of here, you can't stay. I have said this repeatedly.'



'Oh, lieutenant., I shouldn't be here alone. I ask you not to leave, I ask you to disappear, I don't want to see you here again, ever!'



If you still believe that your silence is to your advantage, you're very wrong.

What happened then, at the hospital? When T. Kemény and his son J. Kemény arrived, escorted by police, the consultant received them. She explained to T. Kemény that he could look forward to a long stay at the hospital. T. Kemény looked at her and answered: 'We'll see.'

After 11 days in captivity T Kemény and his son were temporarily paroled and went back to the devastated house. They found all documents and books. The documents were charred but still usable. They arranged the paperwork and then showed all documents concerning the paternity issue to the consultant, the ward physician and the nurse. There were also pictures of the family and little Tibor. After all three had read the documents, the consultant stood and said this: 'Bloody hell, I was fooled, it's all lies, fiddling and fraud. I understand you now, Tibor.' She was very angry. After six months, T. Kemény was released from Långbro hospital.

Head of State, what do you say about this phenomenon?
I continue:

Personal contact was established with Krister R, who said, on the phone, that he didn't know T. Kemény and his family and he did not know what it was all about. Thus, he knew nothing about the paternity issue or his allowance via the legal system. Neither did he know anything about the blood examination connected to T. Kemény's paternity.

Briefly: You have created hell for this Krister R. And it's still OK?'



'I'm leaving you in peace and quiet.'



'By the way, I remember another issue. Pope John Paul II visited you here at the castle and the Arch bishop in Uppsala in 1969, but Palme did not die until 1986.'

Pope John Paul II visited the royal families in Copenhagen and Stockholm and the Arch bishop in Uppsala in the summer of 1989.

What did you talk about? The paternity issue, the Palme murder...?'



'Our discussions are not for your knowledge. I'm still the Head of State, laws and regulations do not apply. You'd better remember that.'



'I understand, you are the Head of State, laws and regulations are not there for YOU. That's why T. Kemény's paternity issue looks like this.'

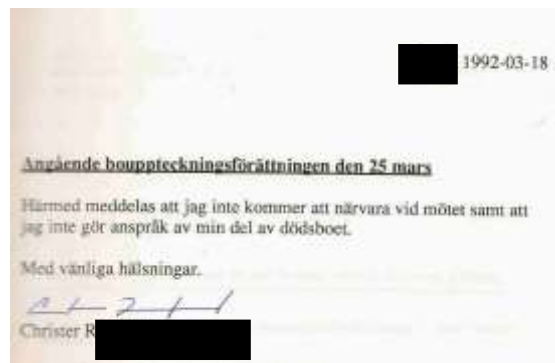
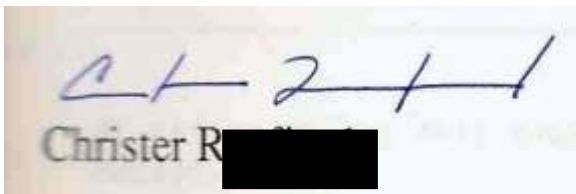
After Pope John Paul's visit to you and the Arch bishop, you were promptly invited to the Pope in the Vatican on November 13, 1989, at eleven o'clock in the morning. You also took part in a secret conversation with the Pope. What did you talk about? The paternity issue? Or Palme?' ←



'That's correct. I and the Queen were invited to visit the Pope.
The topic of our conversation is none of your business. You do what you have to do, I take care of my job. It's that easy. Leave me alone!'



'It's obvious you don't want to answer my questions. In my job there is no difference between people in the investigation, whether they are heads of state or police officers. I promise to walk out of here as soon as I'm finished.'



After the death of T. Kemény there was an estate inventory proceeding. The appropriate authority wanted Krister R to participate and he was summoned in 1992. He answered that he did not want to participate and that he had no claims. Signed by Krister (Christer) R on March 18, 1992. But T. Kemény was not mentioned in the letter.

'There is one very important issue that will interest you as well. T. Kemény passed away in May 1991. The estate inventory proceedings took place in 1992 and the appropriate authority wanted Krister R to participate. He answered he wouldn't do that and that he had no legal claims. Signed by Krister (Christer) R March 18, 1992.

My question to you is this: Who wrote the letter and who signed it? What does 'no claims' mean? Whose estate is he talking about? T. Kemény wasn't mentioned in the letter.'



'Lieutenant, you are getting on my nerves. I don't think the royal canon fires more balls than the number of questions you've fired at me. I didn't write a letter, neither do I know who signed it.'



It's true that you didn't sign the letter, the signature isn't yours. It's remarkable that nobody knows, the issue is an ongoing one since 1958. My wife, if she was here, might have believed your answer. Who is secretly running this country, if it's not YOU? Who, apart from you, knows about this paternity issue?'



It was about the damages application to the district court here in Stockholm.

In the 2012 - 13 petition, J. Kemény mentioned that Tibor E was about to be operated on at Karolinska in Solna, and that he did not leave the hospital alive. The court probably contacted the hospital and then odd things started to happen.



Swedish media wrote about it: 'Dead body in grave - suspicious murder. An anonymous child's body has been found in an old grave at Katolska begravningsplatsen in Solna. Two burial ground workers reacted violently when they saw a human arm and hand protrude. It was found shortly before ten o'clock in the morning of August 7, 2013.' It is true that a woman was buried there in a coffin in 1969. According to the police, a second woman was buried there in a black plastic sack. Who was the woman in the sack? Could it have been Maria? More info at **Deity**, pp 50 - 51 In his last phone call in 1971 Tibor E promised to get in touch the moment he left the hospital. In 2013 he got in touch with his arm via the manager of the burial site.



Pope Benedict XVI, the Head of the Catholic Church, abdicated on February 28 2013, 26 years after the death of Olof Palme. This coincides with Palme's birth in 1927. In 2012 and 2013 T. Kemény's son J. Kemény handed in claims for damages to the district court, due to the handling of the paternity issue. This procedure had caused a deterioration of the life of the family: illness, depression, mental suffering and financial loss. Especially for the daughter, who was severely affected with a depression from the 70s and onwards. Tibor E, who disappeared, was also mentioned in the claims. In his last telephone conversation with T. Kemény he said he was going to have an operation and that he would be in touch when he left the hospital. He never called, he did not leave the hospital alive. The district court shelved the attachments. District court started his own investigation and contacted Karolinska sjukhuset in Solna. Then odd things started to appear.

'Dead body in grave – suspicious murder. An anonymous child's body has been found in an old grave at Katolska begravningsplatsen in Solna.' The court turned down his claims.

Pope Benedict XVI abdicated on February 28 2013, 27 years after the Palme murder. The abdication reminds me of Palme's birthdate, 1927. This is further evidence of the Holy See's involvement in the murder.

Your comments on this? Church of Sweden and the Holy See walk hand in hand.'



'Lieutenant, how many times must I remind you that I refuse to talk to you. The reason behind his abdication is entirely up to him. I was informed about the burial site proceeding via media.'





'Strange! You're the Head of State and you don't know what's going on in your country. Why are you here? What are you really doing? A head of state must know about everything that's happening in the country. What has happened to the Jewish boy Tibor E, his mother Maria and her husband, the Dane Kristian J? My wife, as I've already mentioned is very kind and friendly woman, she would undoubtedly believe you.'

Anyway, let's go on. J Kemény appealed against the district court's decision with the European Court of Human Rights on March 30, 2014. **Letter #1** weighed 1.2 kilos, **letter #2** 1.3 kilos. The appeal contains documents and evidence concerning the violation of human rights in connection with the brutal and criminal handling of T. Kemény's paternity issue, the issue you are very familiar with.'



J. Kemény sent his appeal to the European Court of Human Rights on March 30 2014, certified with notice of delivery. More info at *Man's Will*. The Court's decision came on May 22, 2014. Very fast indeed.



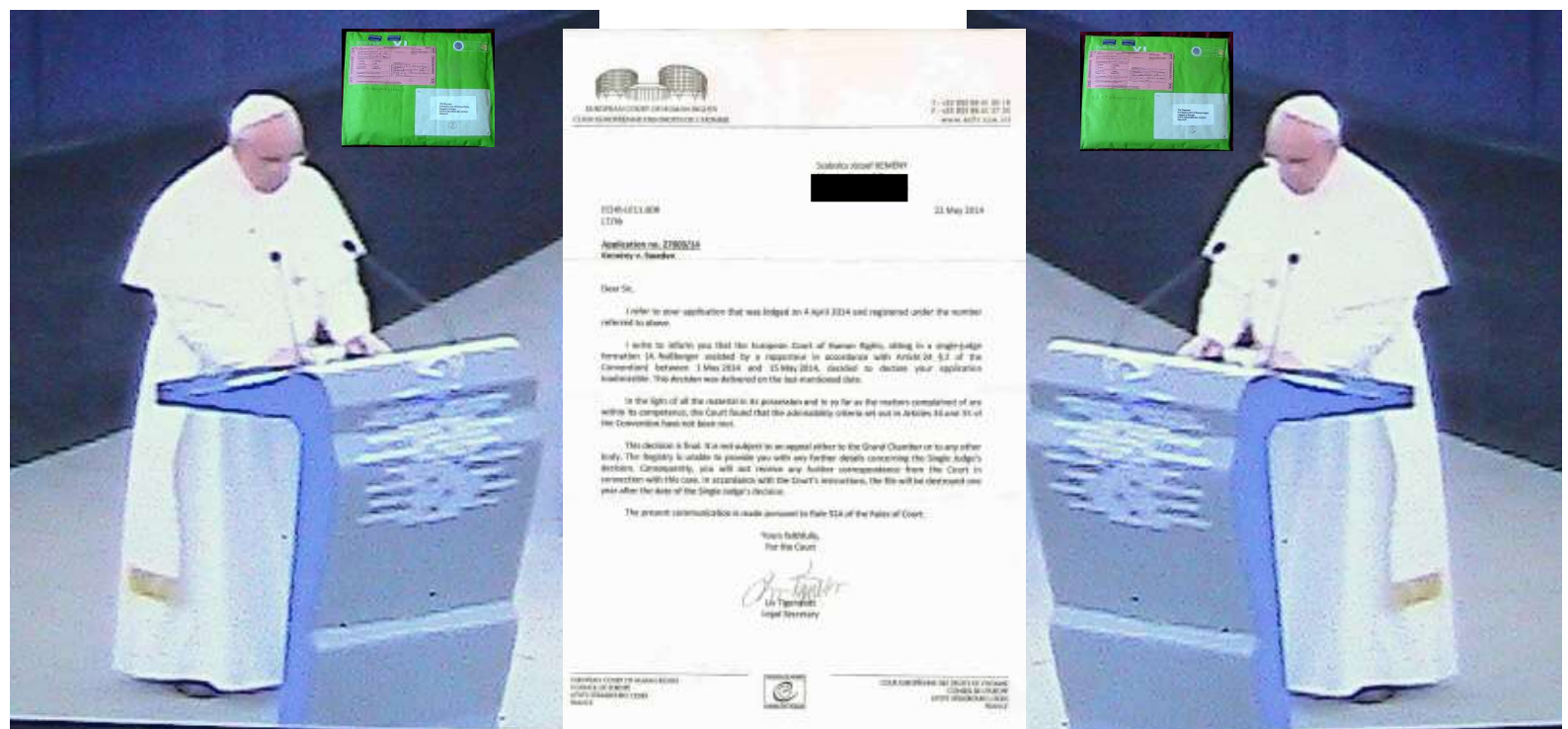
The European Court rejected the appeal. There was only one judge who made the decision, according to Swedish tradition. Judges from other countries were disconnected (Viktor Orbán was probably satisfied

Mr. Head of State, haven't you heard of this European Court case? It's partly directed at you. This paternity issue which Gustav Adolf VI classified at the Castle of Stockholm on March 30, 1966?'



'Cannon balls are hitting me and my castle again. I don't quite remember any court decision in this case. By the way, lieutenant Columbo: no comments.'





The appeal was rejected by the court in Strasbourg in May, 2014. The pope visited Strasbourg in the end of November 2015, a visit prompted by the refugee situation in Europe. A dialogue with Strasbourg was not on the agenda. My belief is that the Pope himself went to Strasbourg to collect all attached documents connected to Kemény's appeal. This Pope, too, can see how inhuman and criminal the handling of the issue has been in the Kingdom of Sweden. The Vatican constantly suggests that they know the truth connected to Christianity. Of course they do.

Cabinet Meeting at the Stockholm Castle, October 3 2014

This final court decision is a catastrophe and shame for Man and Mankind. The King was of the opinion that T Kemény's paternity issue and surrounding incidents were finished. He grabbed the opportunity and took the next step to remain at the centre of events.

This is the King's so-called **trick**. When he performed the trick at the end of the cabinet meeting the sound from the Court was cut. The lady in waiting showed the new cabinet members how to move their chairs to a certain distance from the table, the same distance at each side. The King gave directions and was satisfied with the result. This was broadcast all over the world and the sound came back. Then the King let go of the new government in the name of **Wisdom**. - 'This is an old trick', he explained.

We can see it from the King's and his daughter Victoria's chairs. It forms a 'V' for Victory.



'And you don't remember this! A **V for Victory**, but for whom? Who are you fighting in this country? Who is your opponent? You were clever with the sign of Victory at the end of the cabinet meeting in Stockholm., the government works for you in the name of wisdom.'

266, 110 From a solar eclipse

Karol Józef Wojtyła was born on May 18, 1920, during a solar eclipse. Malachi's motto is *De Labore Solis, From a Solar Eclipse*. He was born 100 years ago and his papal mission was to cover the Sun on this planet. The Sun is a symbol of the Lion, the Jewish boy Tibor E (Messiah of the World) was born in Linköping exactly at midnight on Christmas Eve, 1958. Linköping's coat of arms depicts a Lion. Tibor E was murdered in 1971, Olof Palme was the Prime Minister and Gustav Adolf VI Head of State. The Pope summoned Palme and during a top-secret conversation asked Palme to confess that he had issued the order to kill Tibor E. Palme refused. The Pope made his decision.



The Holy See secretly contacted the CIA and declared that the Agency should take care of the assassination of Olof Palme. The operation was to be executed in a way that would forever hide the instigator, the Holy See. In other words; Palme would be assassinated and the Vatican would know nothing about it.

CIA thought a lot about it. How could they remove Palme without and religious connotations and attention, the murder was supposed to be political. They knew that Palme always sided with the weak and oppressed. One example was South Africa, where the **apartheid regime** was in power. CIA contacted President PW Botha in South Africa and they agreed to assassinate Palme as South Africa's primary enemy. The secret meeting took place during 1985. President PW Botha issued his order to MI and MI contacted Craig Williamson, LONG REACH. Preparations for dirty and bloody proceedings were initiated. It is not an easy operation to kill a prime minister in Europe, the Nordic countries. He and his agents worked for the Military Intelligence Agency and his company, Long Reach, was part of the fearsome security agency BOSS (Bureau of State Security). There were other possible motives such as the Iran-Contras affair. He probably knew about the dirty work carried out by the CIA on this issue, after he had said no to the US when they wanted to use the Swedish weapon manufacturer's legal route.

They planned to carry out the operation during the anti-apartheid conference on February 20-21 1986. Palme and the ANC leaders *Tambo* and *Mbekis* were conference participants. The occasion was deemed unfavourable and they had to postpone the operation.

Super spy Craig Williamson and his company LONG REACH received the assignment. The operation got the codename *Slingervel*, Afrikaans, or *Slingshot*, English. It was general knowledge that Bonn and Brussels were centres of the apartheid regime's activities in Europe. NI's (National Intelligence) representative in Bonn was assigned to procure the hardware, the murder weapon. The operation needed Swedish contacts and a group called 'Uppsalagruppen' was formed. They were well equipped with extensive contacts with Long Reach and other individuals and organisations.

CW goes on with what he has to do and adjusts the plan.

The enormous security arrangements gave the observers an opportunity to watch over Olof Palme's and the ANC-leaders' movements in Stockholm and stopped all possibilities of attacking Palme. The following week he visited some small communities in the north of Sweden. It is reasonable to believe that CW and his assistants remained in Stockholm, awaiting the next opportunity when Palme would return home and move around without protection from his home at Västerlånggatan 31 – where Lisbeth Palme caught sight of 'shady characters.' And it is probably now that CW is recognized, Swedish contacts must have contributed information (Uppsalagruppen) about Palme's return to Stockholm. Maybe it was decided to do something on Friday 28 when he was back home – Operator 1, 'Allen' was informed.

There is information fro two police sources that Craig Williamson spent the night with the Stockholm branch of the International Police Association, IPA. Operator Allen arrived from Denmark Guest House to hotel Wellington on February 27 in a rental car. Eugene de Kock was staying at Hotel Lord Nelson in the old city of Stockholm, just a couple of yards from Palme's home. The most professional men in this context were close to Palme's home.



‘Lieutenant, you needn’t go on. You’d better stop here. I’m not curious of what happens next.’



‘I know that the Palme murder is an uncomfortable story for you. I will soon stop this brief account, just let me go on.’



Friday, February 28. In the afternoon there were discussions at Lisbeth Palme’s workplace about a possible visit to the cinema. A film at the Grand popped up in a phone conversation with her son’s fiancé at around five o’clock pm.

Palme, who had earlier dismissed his lifeguards, got to know about the cinema plans when he arrived home at around 6.30. He discussed this with his son Mårten on the phone, he had already bought tickets to the Grand, but nothing was decided. The Palme couple decided to go to the cinema at around 8 o’clock. All telephone conversations were tapped. On that particular Friday, Palme arrived home at Västerlånggatan 31 in the Old City at around 6.30 pm after a normal day at work. He had dinner with his wife and made some phone calls to Bo Toresson and Sven Aspling. Shortly after 8.30 the couple left their home and took a walk to the Gamla Stan underground station. They boarded a train which left at 8.42 and arrived at underground station Rådmansgatan at 8.47. They walked from there to the Grand Cinema at Sveavägen, where they met their son Mårten and his fiancé shortly before nine o’clock. Palme bought the tickets to ‘The Mozart Brothers’, a film by Suzanne Osten. It started at 9.15.

After the film, between 11.05 and 11.10, the four of them lingered outside the cinema to 11.15 when they parted and Lisbet and Olof Palme started to walk southwards along Sveavägen. At Adolf Fredriks Kyrkogata they crossed the street and then continued their walk home. It was a relatively slow stroll and they stopped at at least one Sari window display. When they, at around 11.21.30, passed Tunnelgatan and the Dekorima store, a man approached Palme from behind and shot him at close range in his back, a bullet that killed him immediately. A second shot touched Lisbeth Palme’s back. Then the perpetrator ran long Tunnelgatan, took the steps up to Malmskillnadsgatan where he continued across the street and down David Bagares gata. After that, there are no traces of the fleeing perpetrator.



'Lieutenant Columbo, I've heard this story at least a thousand times during all these years. You can never present anything new in this context.'

'You seem to be in a pensive mood, Head of State. Maybe you remember something from that evening?'



'I agree, you've heard about this incident for 34 years. There is a time for everything. I'm a bit curious about how you will react when you hear the end of this story. Let's go on.'

It is a fact that Palme's telephone conversations were bugged before the murder. Super spy **Craig Williamson** carefully ran the operation, he had a lot of time. He placed Operator 2 in a car outside the Grand. If Palme and his wife took a taxi home, he would follow and then kill them by their home in the Old City. He placed Operator 1 at the crossing Sveavägen - Tunnelgatan. He was going to shoot them there, if they took a walk home. He was at the centre of the operation and talked to them using walkie-talkies. Palme and his wife decided to walk home. Simultaneously, **Craig Williamson** had placed another car at David Bagares gata, Probably from Uppsalagruppen.

Operator 1 waited for Olof and Lisbet Palme and at 11.21.30 he fired two shots at close range. One bullet hit Olof Palme and the other just touched Lisbet. He then ran via Tunnelgatan to David Bagares gata, where a car was waiting for him. It quickly took him to Bromma airport, where he boarded a private jet which took him to Amsterdam, where he booked a room a Guest House on February 29, 1986. He brought the gun.

The first important question is why a professional misses the second shot at close range. The only possible answer is that he was disturbed, in that situation it is easy to miss. After having fired the first shot, he looked back and probably saw a man running towards him. The man looked like **Craig Williamson**, that is why he missed the second shot.



The pictures indicate that the s-called Skandia man, **Stig Folke Wilhelm Engström** and super spy **Craig Williamson** look like each other and in an unexpected situation it may be difficult to keep them apart. It is possible that he was the first person to arrive at the scene. Shortly thereafter a nurse appeared, she took care of Palme.



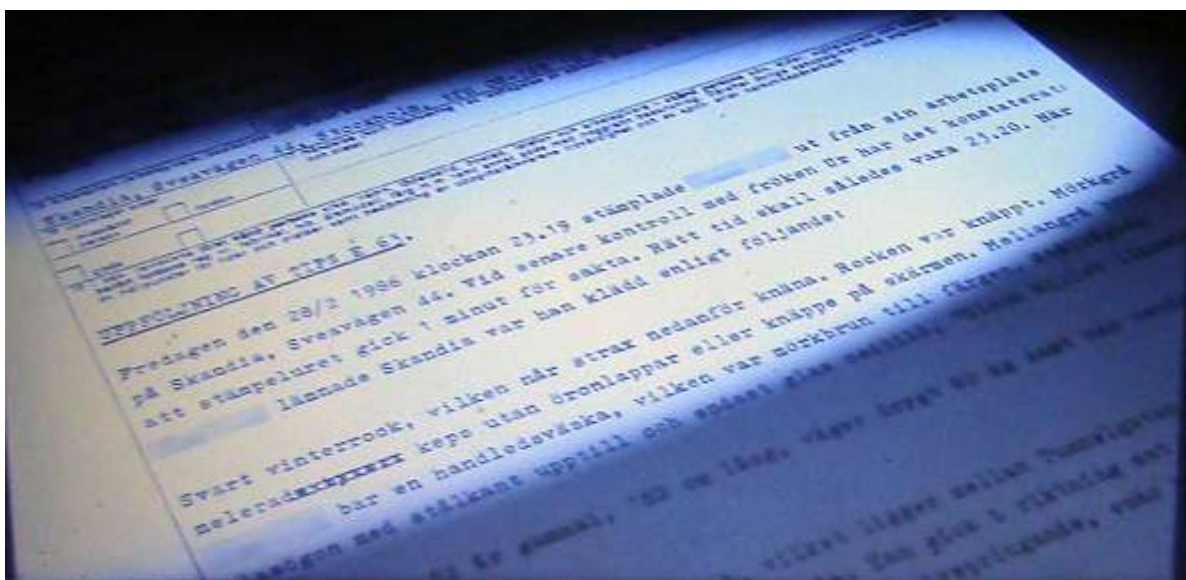
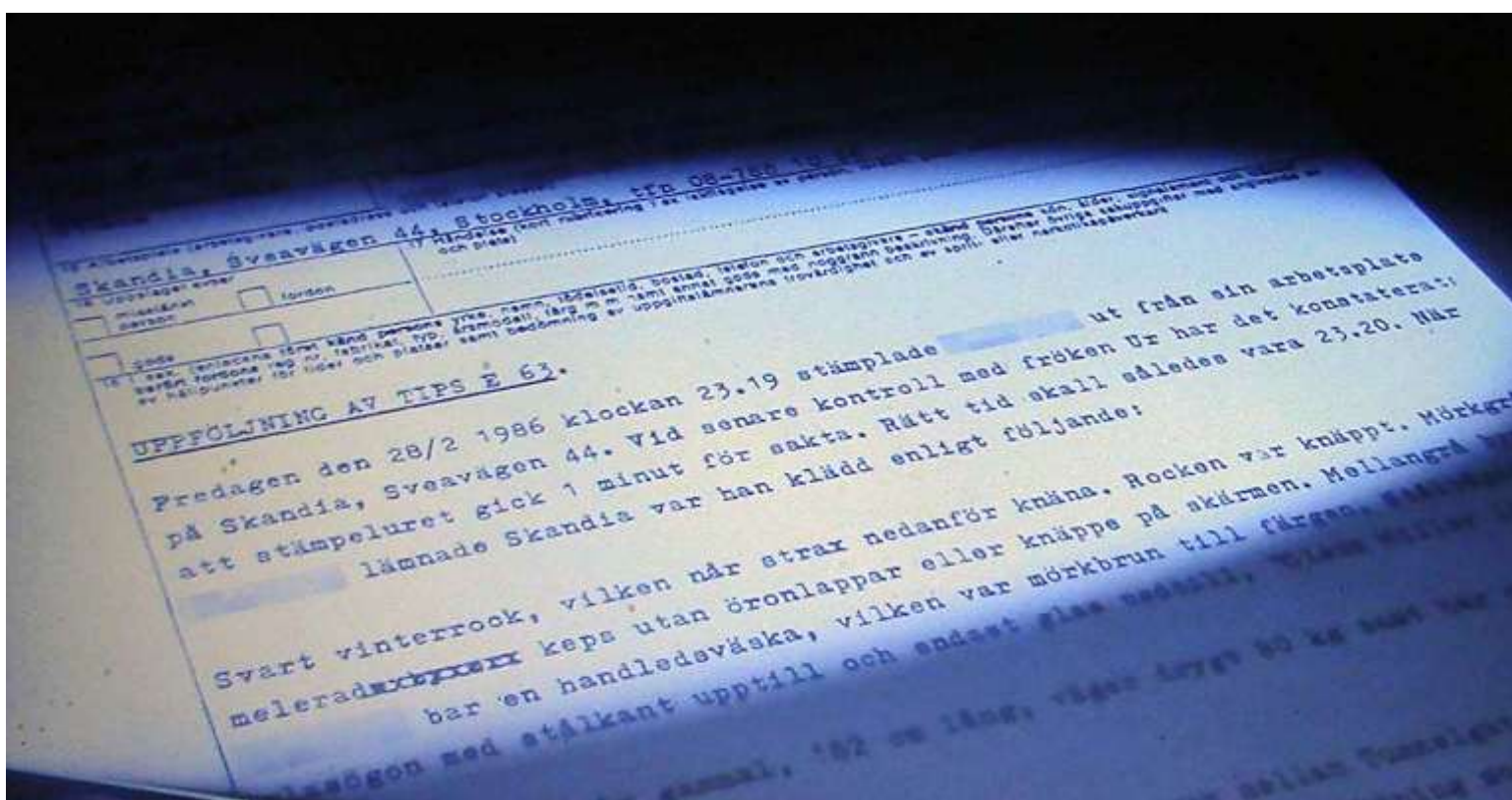
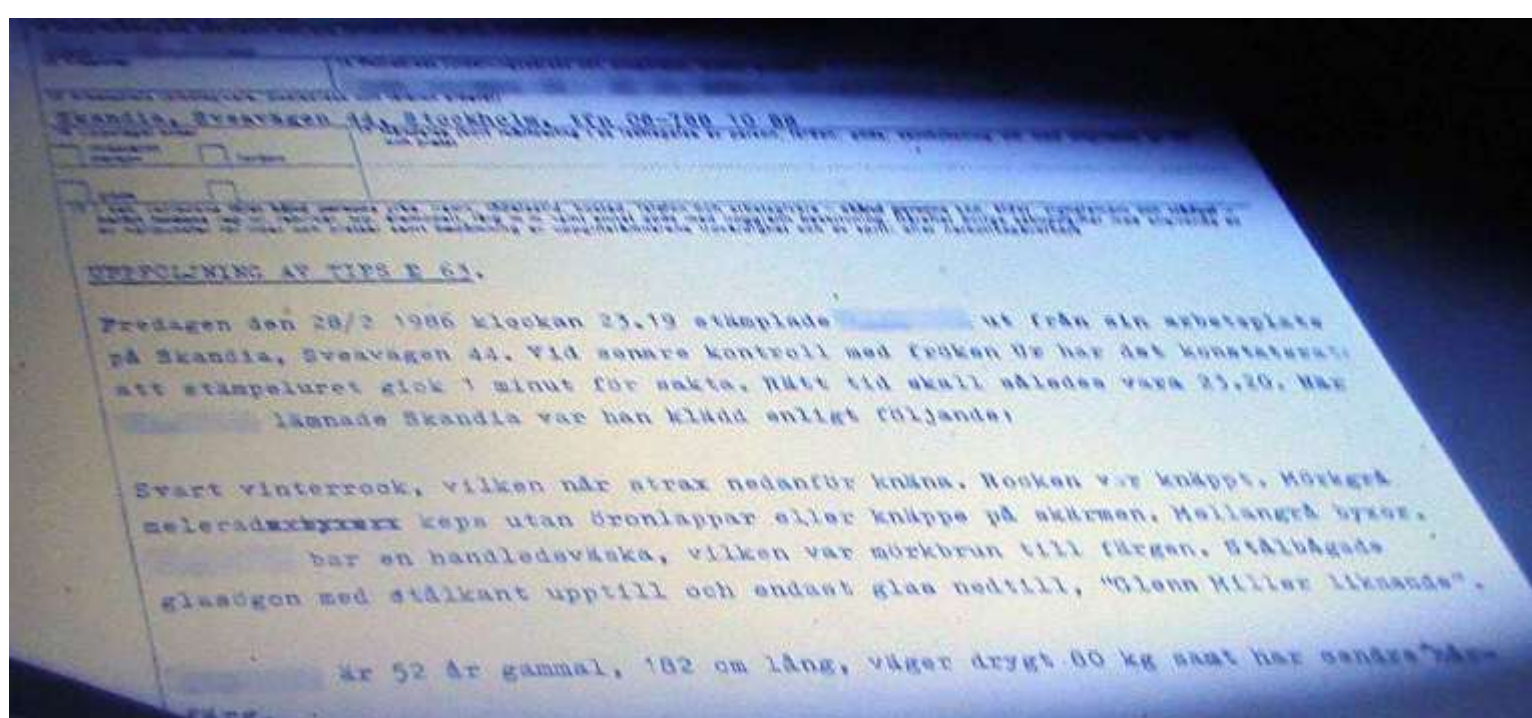
A reconstruction of Engström's intensive evening, at 11.19 pm after work at Skandia, on his way to catch the underground.



On April 6, 1986 Engström appeared in a tv show, where his fast transportation home was reconstructed. He had left his work late in the evening, at 11.19. His place of work at Skandia is located at Sveavägen 44, 50 metres from the crime scene where Palme was shot. He left his work and was on his way to catch the last train home. On the level with the advertising pillar, he had a look at his watch to see if there was time enough to catch the train, at the same time he heard two shots. Five seconds later he is said to have arrived at the victim. He helped with CPR and when the police eventually arrived at the scene, he indicated the murderer's escape route. He said that the policemen took were not very interested until the ambulance arrived. When it arrived, it was clear who the victim was.

He said this about police activities: **When you say you're doing a jigsaw puzzle and are trying to get rid of pieces which do not belong, you shouldn't get rid of the important pieces.**

A very good early motivation from him. He was completely right about the fake activities of the police.



Police records of Engström's report of the observations connected to the Olof Palme murder. They connect to the above pictures, but the dark brown clutch bag is missing. – The murderer didn't carry a clutch bag.



According to police documentation, Operator 1 could have observed Skandia Man almost running towards him after having fired the first shot and then missed the second one. Operator 1 thought it was super spy **Craig Williamson**. Skandia Man was sturdy and strong (182 centimetres, 82 kilos) just like Williamson, he also had a clutch bag. Practically, this chain of events could mean that it was the sudden appearance of the Skandia Man which saved Lisbeth Palme's life. The only wrongdoing by the Skandia Man was that he hurried to the underground, he knew nothing about the carefully planned murder of Palme. When he looked forward, Operator 1 was already gone. According to him, he arrived at the victim after five seconds. He saw a man on the ground, a shocked woman beside him. We can add that, according to the illustration, the murderer was behind the couple. This means that Lisbeth Palme had to turn round a bit in order to see him.



'You mentioned that there is nothing new to add. You, who are the Head of State in this country certainly know about which illegal, criminal, foreign organisations which were active in the capitol of this country? As you can see, much is new, very much, even too much.'

'Lieutenant Columbo, your questions make me tires. If you have more of them, join the queue and ask the police. I have nothing more to say.'



'I can see you have no patience. A Head of State should havet hat. I hope my wife is better than that and waits for me. But before I leave you, I have a brief conclusion for you.

Let me go on.'



Super spy **Craig Williamson**, LONG REACH

South Africa, born in 1949



It is possible that Super spy **Craig Williamson**, LONG REACH, South Africa, was the most important and dangerous spy in those days. He was a clever organiser, he knew what he was doing. It is no surprise that he got the assignment to kill Olof Palme. At the time of the murder, Craig Williamson spent the night at IPA, the International Police Association in Stockholm. He was seen in the Old City of Stockholm, outside Palme's home, in company with other suspicious people.

Super spy **Craig Williamson**, LONG REACH, South Africa. He, together with Uppsalagruppen, was the brain behind the murder, he was constantly at the centre of events. The main investigators also know about his visit to Stockholm at the time of the murder. There is no information on when and how he left Stockholm, everything, including his surroundings, was top secret. He probably left by private jet. Head prosecutor Jan Danielsson has confirmed his whereabouts in Stockholm.

He never acknowledged his visit to Stockholm during the Palme murder. It is understandable. His activities in South Africa were legal, his co-operations with other organisations, including Uppsalagruppen, caused no problems. In a number of South African documents he appears as the brain behind the murder of Swedish Olof Palme.

Almost all Long Reach documents have unfortunately been destroyed. A lot of secret material was erased before the transfer of power in 1994.

He, being the boss and owner of LONG BEACH did not shoot Palme, he always used false identities.

Police Colonel **Eugene de Kock**, Prime Evil, SAP South Africa, b 1949



Police Colonel **Eugene de Kock**, 'Prime Evil'. His story begins as early as the week before the Palme murder at the end of February 1986, when he was staying at Hotel Lord Nelson in the Old City of Stockholm. Palme's home was just metres away. In several documents we can read how State Security Council in South Africa regarded Palme as an 'Enemy of the State', which equals a death sentence, he had gone too far in supporting the ANC.

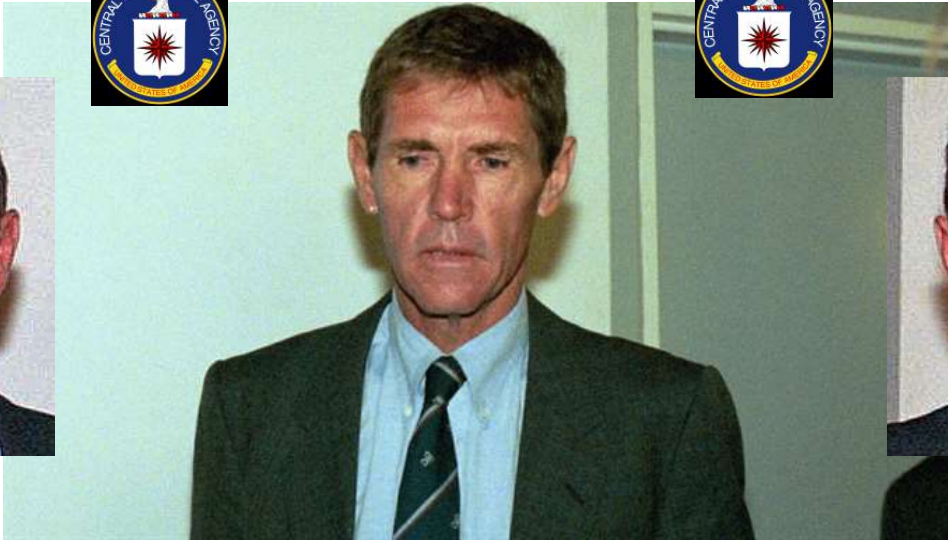
On March 1, the day after, thick hair the murder, police intensify the border controls. On the pictures above is a man who shows his passport at Arlanda airport on his way to leave the country. The passport is a forgery. The man has a dark coat, a peaked cap and glasses. He had an eye disorder which made his look glassy-eyed. His name is **Eugene de Kock**, South African police colonel. He demonstrates all characteristics Eugene de Kock is known to have: glasses, big chin, thick hair, wide whiskers, stooping and sturdy back. He often wears this kind of coats with an open collar.

10 years after the murder things start to move again when the former police colonel in South Africa, Eugene de Kock, starts talking to the Truth Commission about his involvement in the **Palme murder** and the **Palme group**. He reveals some issues and refers to **Craig Williamson** who planned the murder and to Operator Anthony White who shot Palme. Why did he reveal South African involvement in the murder? Something went wrong and the result was not what they expected. Facing the Truth Commission, they all tried to save their own faces. The same thing happened to Eugene de Kock, he was also involved in the murder. He was the boss, he did not kill Palme.

Nelson Mandela told Lisbeth Palme that he suspected the South African Squadron of Death. In March, 1990, the South African President Nelson Mandela met Lisbeth Palme in Cape Town. He held her hands and said: 'Isn't it terrible that there seems to be a connection between the South African Squadron of Death and the murder of you husband?'

In April 1994 Mandela visited Sweden – prior to his departure he told the journalists that he could not 'exclude the possibility' that the apartheid regime was involved in the Palme murder.

Operator 2, **Anthony White**, LONG REACH, South Africa,



Operator 2, top soldier **Anthony White**, was a member of LONG REACH at the time of the murder. He, too, was in Stockholm. We do not know where he stayed, maybe at the Wellington Hotel? But people saw him close to Palme's home and the Grand Cinema.

According to the anonymous witness he was spotted in Säpo's corridors only days after the murder (Säpo: Swedish Security Service).

'According to the woman, White appeared, between two Säpo officers in suits, in the corridor dressed in jeans and a white t-shirt. They entered a lift which took them directly to the garage, Säpo's 'secret' lift. White looked tired. The woman noticed him because he rarely appeared in the building' according to journalist Lars Borgnäs. After the murder a facial composite was released.



The facial composite faintly resembles Operator 2, White.

Several witnesses also saw him using a walkie-talkie, as did Eugene de Kock and **Craig Williamson**. Moments after the murder there was a radio announcement which leaked the incident and stated that the perpetrator had left the country. A female police officer saw White in the Säpo corridors after the murder together with Säpo officers, which means that White did not kill Palme. In that way the facial composite is, in fact, misleading. White and **Craig Williamson** probably left the country in a private jet.

He laid the foundation to the idea that the future Palmegruppen should avoid South Africa. In other words: **South Africa was to be removed from the Palme murder and the investigation.**

CAPT. ROY ALLEN



Operator 1, Captain Roy Allen joined his group called *Slingervel* (Afrikaans), or *Slingshot* (English) on February 27 from Denmark. He came to Stockholm in a rental car (according to the invoice to **Craig Williamson**) and booked a room at Hotel Wellington the same day. Being Operator 1, his assignment was to shoot Olof Palme when convenient, that is why he went to Stockholm. His assignment was changed at the last moment, he was assigned to kill Lisbeth Pale as well. Just before the attack, he removed his glasses to avoid recognition. His first shot was okay, but when he fired the second shot something unexpected happened, and he missed. It is probable that he turned around and saw an individual looking like **Craig Williamson** almost running towards him, and he missed. One question is whether he was short-sighted or long-sighted. Shortly after the murder he was brought to Bromma Airport by a member of. He probably talked to **Eugene de Kock** using his walkie-talkie and told him why he missed the second shot. He brought his weapon to Holland, where it was probably destroyed. The weapon was probably made in Bonn, Germany, exclusively for this assignment. If we take a look at his invoice with **Craig Williamson** as the addressee, there is no reimbursement for the completed assignment in Stockholm. Why? He only carried out half the assignment which makes it a failure, no reimbursement was expected. It seems as if Kock believed in Allen and grew suspicious towards Williamson. de Kock's return trip is also interesting. Was he supposed to accompany Williamson? - On March 1 he took a commercial flight from Arlanda where he was photographed, evidence that he was here in Stockholm. Something had happened between Eugene de Kock and Craig Williamson. de Kock told the Truth Commission that it was **Craig Williamson** who planned the murder and A White who shot Palme. He defended Allen. Why did he disclose operation *Slingervel*, which was a classified assignment initially known to only a few people? President Botha's security organisation fell like a house of cards. It is self-evident that Allen denied any visit to Stockholm.

INTERNAL MEMORANDUM:

CHIEF STAFF INTELLIGENCE

REGARDING THE PROPOSED ACTION AGAINST THE ENEMIES OF THE STATE IN EUROPE.

Further to the verbal briefing by Brig. T.Botha the following questions need to be addressed please:

1. Is the code name of the Operation "SLICKERVEL" or "SLINGERHÖT" ?
2. It is understood that the Operational Field Command is the responsibility of Long Reach. It is unfortunately not clear who will direct overall command of the Operation ? This is necessary for planning and logistical support that would be needed.
3. Who will be making a ~~personnel~~ operator that will be deployed for the final phase of the operation? It should be noted that Long Reach have qualified personnel that could be made available but it would be advantageous to attach an operator from the Special Forces, with European experience, to Long Reach for that period.
4. The proposed budget is acceptable and no difficulty is foreseen.
5. The final date for the commencement of the operation in total would have to be the second week in December 1985.

SUBJECT: ANTI SOUTH AFRICAN ACTIONS: SWEDEN.

1. Further to previous Intelligence Reports circulated, (MI Reports dated 17 January 1985, 9 April 1985, 19 September 1985) the following have to be brought to the State Security Council's notice:

- 1.1. It has been confirmed that Anti Apartheid Movements would be congregating in Stockholm, Sweden during February 1986 for a conference.
2. Reliable Swedish Sources confirmed that Mr. Palme's sympathies towards the U.S.S.R. have caused grave concern in Sweden and that these sympathies would most certainly have a detrimental effect on the influence of the U.S.S.R. in Europe and Africa.
- 2.1. Mr. Palme can be seen as a major contributor against South Africa and should now be seen as an Enemy of the State.
- 2.2. The previously suggested action against Mr. Palme should now receive urgent attention. *Sten Sævi*
3. The Anti Apartheid Conference in Stockholm, it is suggested by our Swedish Sources in Uppsala, would present the ideal opportunity to take the necessary action against Mr. Palme and it would be possible to ensure that the action be attributed to other groups.

Behaving

'Mr. Head of State, I have now given you a summary of the murder of your prime minister. There is plenty of evidence that South Africa was behind it all. How come that foreign agents operate in the Kingdom of Sweden assisted by Swedes and Uppsalagruppen and you know nothing about it? How is national security?'

'Lieutenant Columbo, for how long are you going to talk about this? Are you planning to stay in my guestroom? We now have a very competent Palmegrupp, they are working the case. Have a look at that, too!'



'I agree with you, you have a very competent Palmegrupp, they are very conscientious. I have looked back a few years and have found this about Palmegruppen's activities, e.g. a visit to South Africa.'



'Several independent sources among South African politicians, legal system and police bear witness that the then head of Palmegruppen, Hans Ölvbro and Prosecutor Jan Danielsson, almost apologized for bothering their hosts when they visited South Africa to investigate the South African connections. They even hinted that they had come only because of pressure of opinion in Sweden. They said they already knew who killed Palme (Christer Pettersson). One source says that Jan Danielsson was reading the newspaper while Hans Ölvbro asked irrelevant questions. Ölvbro did not take notes.

'Sure, you have a competent and polite Palmegrupp, they have made the murderer Swedish, according to instructions from A White.

← Your comments? →

'No, no, no, enough is enough. It's a labyrinth, neither in nor out. There are many motives and many comments, nobody knows about the origin. Not even you.'



'We're approaching the end. Now I will show you something that is new to everybody else.'



We know that Palme, before he went to the cinema, dismissed his lifeguards and he did not wear a flak jacket. He knew he was about to be killed according to a decision made by Pope John Paul. It was because he did not assume responsibility and declared that he gave the orders to kill the Jewish boy Tibor E during his time in office 1971. He was innocent in this context. To prove his innocence on this day of destiny, he was unarmed, no lifeguards and no flak jacket. We can compare this to Pontius Pilate washing his hands. – In this case the murderer is not the most important person, it is the individual and/or organization who gave the orders. Here we have the Holy See and the CIA, they were behind the murder of Palme and the Jewish boy Tibor E.

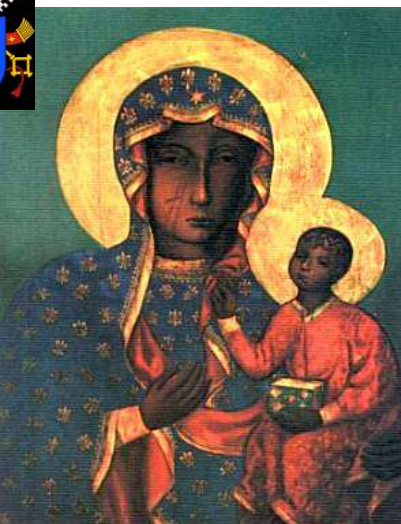

In Memory of Lieutenant Columbo

On February 28, 1986, I visited my female friend from Åbo, with whom I had a good relation for about 15 years. At the time I worked for Ahlsell VVS AB at Hammarbyhamnen. After work, every Friday, I went home to her, to Farsta. She was a very intelligent woman, and we had some interesting discussions.

I will never forget that night, February 28 1986. We were listening to the radio and heard that Prime Minister Olof Palme had been shot. The news came like a bolt from the blue. The question was why and by whom? Then we learned that the murderer had already left the country.

What I did not know at the time was that you do not solve the Palme murder in 34 years. There is a number of books about the murder and possible perpetrators, each one with his/her own motive. The South African approach singles out a murderer. We can praise everybody who has tried to find a solution, they have found lots of interesting documents.

We can briefly conclude that the Swedish people never sleep, except for Palmegruppen. They are fast asleep, fighting their nightmares. My thoughts at the time was to participate, to tell the world everything I knew about the murder. I did not know how, but certainly not in a book. The murders of the Jewish boy Tibor E and Olof Palme are heavy and dark criminal actions by professionals and organisations. Film and tv depict lots of detectives who are solving crimes in various ways, sometimes even with violence and murder. But we need a human detective, an officer who solves criminal puzzles using knowledge, one who has a world-wide reputation and uses human tools such as knowledge. An individual such as *Lieutenant Columbo*, starring Peter Falk. I had in mind a combination of our case (my father's paternity issue and the Palme murder) and Lieutenant Columbo. My father's paternity issue is the world's most important case and the murder of Palme the most public crime in Sweden. In that way I could combine our case with Columbo, put the facts of our issue in his hands, in a symbolic way. This would become **Lieutenant Columbo and the Palme murder**. It is a fictional dialogue between Columbo and the King, the Head of State, a memory of Columbo/Peter Falk, a human ideal for the whole world. 'Think first, and then act in a human way.' Palme investigation closed down on June 10, 2020

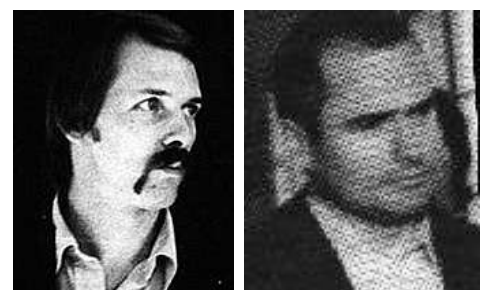
At a press conference, Chief Prosecutor Krister Pettersson singled out the only possible murderer, Skandia man Stig Engström. There is no evidence, no motive and Engström does not make you think about a murderer. He is now dead, which means that the Palme investigation is terminated.

Let's return to the crime scene on February 28, 1986, and let's focus on Palme's last day at work, the day that would end in tragedy for the Palme family. He started the day by playing tennis with a good friend at the Östermalm Sports Arena. He was then driven by Säpo staff to Rosenbad and the Government Offices where he was to attend several meetings. He met the Iraqi and Norwegian ambassadors, thereafter an interview with a Swedish magazine. 'Statsanställd.' When the photographer wanted Palme to stand by the window for some photos, Palme said no '**You never know what's out there**'. This answer, which later on became a classic, stayed in the sinister atmosphere of the office during the rest of the interview. No more photographs were taken. Outside Palme's home in the Old City Lisbeth Palme saw anonymous men outside the apartment before the murder. At 6.15 p.m. he left the Government Offices. He would never return. There was somebody out there who wanted to do evil things. This was Palme's last day at his office. It is very clear that he felt pursued by unknown individuals.

What was most remarkable that day was the evening visit to the cinema. Whose idea was that? Lisbeth's, Mårten's girlfriend's? Who came up with the idea? Neither Palme nor his son Mårten knew about it until late. Was it super spy **Craig Williamson** who sent the idea via Uppsalagruppen, either to someone who knew Lisbeth Palme or to someone who knew Mårten's girlfriend? Simultaneously, Stig Engström was working at Skandia at Sveavägen, he had no idea what the Palme family were up to. **Craig Williamson** and his team watched Olof Palme and his family during one week and time was nearly up, they had to do something. The Grand cinema was the best option for **Craig Williamson**, to arrange a family night out with a film. Here is the core. Killing a prime minister is not easy. You'll need careful planning and world-wide contacts. Besides South Africa, Chile/DINA (according to certain sources) was part of the planning and operation. South African documents have stated that the weapon was to be collected from Bonn, West Germany, no personal names on the documents. The weapon was probably picked up in Bonn by two professional murderers from the security agency DINA, MICHAEL TOWNLEY and RT. According to JARA RIOSECO, Michael Townley and RT arrived at Bonn, West Germany, from Santiago, Chile. They stayed at the Chilean embassy. After around two weeks the men left Bonn and travelled to Kastrup, Denmark. They were spotted by JARA's source as they boarded the flight to Stockholm, where they disappeared, probably protected by the Chilean embassy.

Operator **1**, **Roy Allen's** invoice to **Craig Williamson**, informs us that he came from Holland to Denmark on February 26, 1986, and that he went to Stockholm the following day, to hotel Wellington. Were there plans that Townley and RT were meet R. Allen in Denmark to hand over the weapon?

After Allan had shot Palme, his escape was assisted by an individual who was near the scene, a member of Uppsalagruppen. His assignment was to take Allen to Bromma airport, from where Allen left Sweden, he brought the weapon. It is well known that the individual who was waiting near the scene of the crime was the so-called 33-year-old man, Victor Gunnarsson, a member of Uppsalagruppen. He knew about the evil plans. Then strange things happened. One of them: he confessed he had killed Olof Palme. Did he promise Allen that he would assume the guilt? He did just that. Then he moved to the US, to the Watauga County in North Carolina in the autumn of 1986. There, he informed everybody that he had killed Olof Palme.

The day before Christmas Eve 1983, there were reports that Gunnarsson had disappeared weeks ago. In mid-January 1994 his almost totally naked body was found in the forest area Deep Gap around 300 kilometres from his Salisbury flat. He had been shot twice in the head with a .22 calibre shotgun. Time of death could later be estimated: some time between December 3 and 4 1993. A trial was started in June 1997. The defendant was Lamont C. Underwood, a **former police officer**, who was later convicted and was sentenced to serve lifetime in prison and an additional 40 years at a facility in North Carolina. (Was the CIA behind the murder?) – As far as I understand, Gunnarsson knew too much and he could not keep his mouth shut.

LC Underwood has constantly denied being the murderer. He has also found important witnesses who were never heard in the trial and this has caused civil-rights organisations to act. Underwood was supposed to have executed Gunnarsson on December 4, 1993. He kidnapped his victim from his home in Salisbury and killed him with two shots. If Underwood did not kill Gunnarsson, who did? The CIA? Who is Gunnarsson's murderer, who ambushed and killed him from behind?

He was arrested on March 8, released in the evening. A new interview took place on March 12 and on March 17 the prosecutor decided to remand him in custody, but he was released on April 11 due to lack of evidence.

During the actual murder he was working overtime at Skandia to earn money for a ski holiday, he knew nothing about the Palme murder. On June 10, 2020, the prosecutor claimed that Engström shot Olof Palme.

The murder of Olof Palme was a very special case. Palme was the Prime Minister in 1971, when the Jewish boy Tibor E was murdered. But he did not give the orders to remove the little boy. We all know that all South Africans suspects denied any presence in Sweden. The only one who confessed to the murder was VG who was in the vicinity when Operator 1 shot Palme. 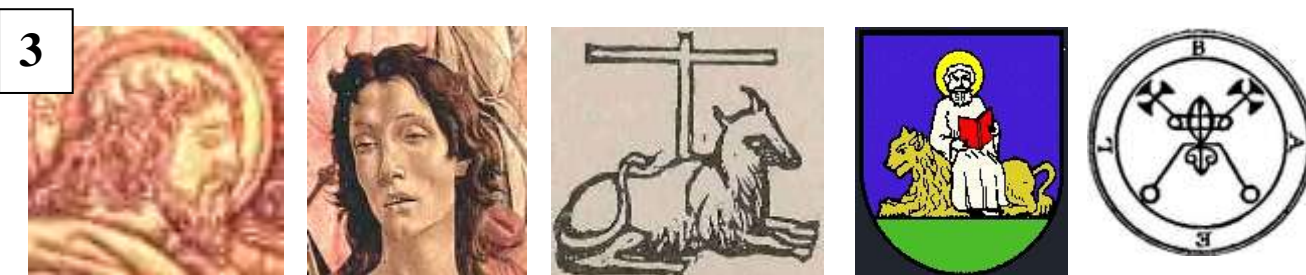

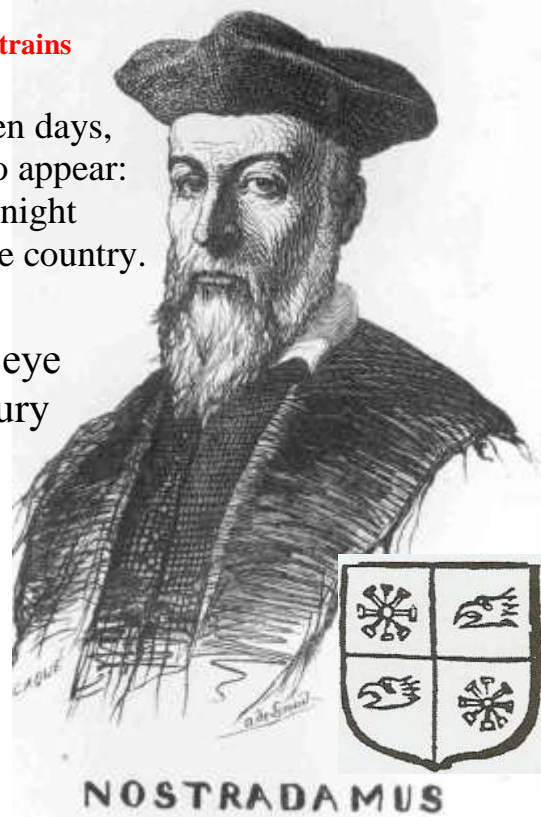
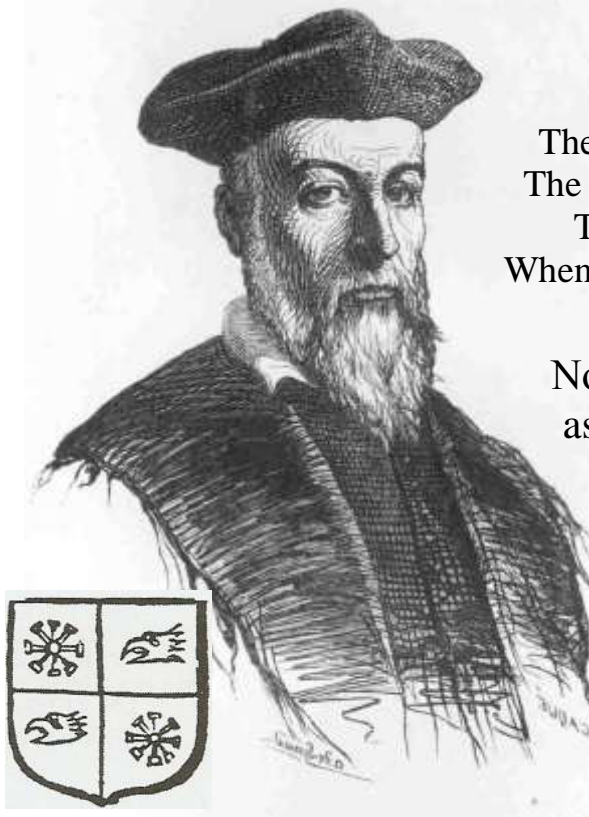
